

# CASTLE RANCH, INC.

STALLION SERVICE CONTRACT FOR Kids Cool Kid  
DOES NOT GUARANTEE BREEDING UNTIL RETURNED WITH DEPOSIT

This certifies \_\_\_\_\_, here referred to as mare owner, has engaged one service to Kids Cool Kid for the mare \_\_\_\_\_ Reg. No. \_\_\_\_\_ for the 200\_\_\_\_\_ season at \$\_\_\_\_\_, live foal guarantee. Castle Ranch, Inc., agent for the above named stallion will herein be referred to as Breeder.

This service is subject to the following:

1. A booking fee of \$\_\_\_\_\_ of the above fee is payable with this contract and the balance of \$\_\_\_\_\_ plus all unpaid expenses will be payable upon receipt of an invoice or when the mare leaves the farm, whichever is first. The Breeder requires 48 hours advance notice when the Mare Owner wishes to remove his mare(s) from the farm. This will allow us sufficient time to prepare the final statement so the Owner may settle his account. If more than one embryo results then the mare owner shall pay an additional stud fee.

2. 1.5% interest will be charged on all account in excess of thirty days.

3. A photo static copy of registration papers (both sides) is required. Equine Influenza, Eastern and Western Encephalomyelitis, Rhinopneumonitis Vaccine, Tetanus Toxoid, West Nile, Rabies and Streptococcus Vaccines must be given before the mare arrives. Vaccinations, deworming and medications may be given at Castle Ranch, Inc.'s discretion at Mare owner's expense. A current Coggins test shall be furnished upon delivery of mare to the breeding farm.

4. Veterinary expenses will be billed separately and paid to the veterinarian.

5. The Mare Owner shall agree that each mare offered for breeding shall be in sound breeding condition and free from infection or disease and halter broke. Any mare certified by the attending veterinarian not to be, in his opinion, in sound breeding condition shall not be bred. A Mare owner may substitute another mare within that breeding season.

6. The Breeder agrees to diligently try and settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If, however, the mare does not settle, the Breeder shall not be held responsible. There will be no guarantee of a live foal for any mare leaving Castle Ranch, Inc., before being checked and pronounced safely in foal at 30 days by the attending veterinarian.

7. Live Foal Guarantee. Live foal means the foal shall stand and nurse. It is understood that, if the mare proves barren, aborts her foal, or if the foal is stillborn, A RETURN SEASON WILL BE GUARANTEED THE FOLLOWING YEAR ONLY, providing proper notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare owner certifies that such abortion or death did not result from any act or omission of the Owner subsequent to the mare's departure from Castle Ranch, Inc. There will be a \$300 rebreed fee.

8. Waiver of Liability. It is understood that the breeding farm; its owners, employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. The above named Mare Owner, whose horse(s) are under the care of Castle Ranch Inc., will not be liable or responsible for any damage, injury or death to the breeding farm stallions, employees, veterinarians, or other animals in the care of Castle Ranch Inc., whether or not caused by his horse.

9. The breeding season in force for this contract shall begin February 1st and close June 15th of the year covered by this contract.

10. If the stallion dies or becomes unfit for service before the Mare is settled, the Mare Owner may declare this contract null and void & receive a full refund of the Stud Fee less booking fee or substitute another mare that is agreed by the mare owner and breeder.

11. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of the birth of the foal.

12. The booking fee shall not be refundable.

13. When the above named Mare Owner signs and returns one copy of this contract to the Breeder it will then be a binding contract on both parties subject to the above terms and conditions. This contract is not valid unless completed in full.

14. There is no Paint Color guarantee.
