AMENDMENT TO STALLION SERVICE CONTRACT FOR TRANSPORTED SEMEN

1. This contract made between Castle Ranch, Inc. and (purchaser) _____ for the mare _____ to the stallion *Kids Cool Kid* for the 20__ breeding season is an amendment to the stallion service contract. The Purchaser may not substitute another mare without the consent of Castle Ranch, Inc. Embryo Transfers are prohibited with out written consent of Castle Ranch, Inc.

2. Purchaser agrees to pay the following fees:
- A. The non-refundable booking fee stated in stallion service contract.
 - B. The balance of the service fee and unpaid expenses as described in the stallion service contract.
 - C. Payment of shipping and courier fees may be subject to change without notice.

All fees and costs must be paid before semen will be shipped.

3. Reservations for shipped semen:
- A. Fresh chilled semen will be collected and shipped on breeding days only.
 - B. All semen orders must be received by 4:00 C.S.T. the day before the requested collection date. Late orders are not guaranteed.
 - C. Semen orders will be filled in this order of priority.
 - i. All mares on premises of Castle Ranch, Inc. will be serviced first.
 - ii. If there is not sufficient semen to fill all orders of a given day, the farm veterinarian will determine which orders will be honored. This decision will be based on the information provided by the purchaser's veterinarian.

4. Conditions
- A. Semen shall be provided only to healthy mares in sound breeding condition as determined by a veterinarian.
 - B. In the event the mare is barren, open, not a maiden, Castle Ranch, Inc. requires the submission of a recent negative intrauterine culture and biopsy.
 - C. In all cases, the veterinarian must certify that the mare's immunizations have been kept current.
 - D. All mares are required to be examined by a licensed veterinarian by palpation and if possible also ultrasound.
 - E. Purchaser agrees to have the mare examined for pregnancy by ultrasound and submit such results along insemination and conception reports to Castle Ranch, Inc. within 14 days after ovulation of that cycle. In the event the mare is barren, Castle Ranch, Inc. may require the submission of a negative intrauterine culture and/or biopsy and/or progesterone assay.
 - F. Purchaser agrees to have mare examined for pregnancy by veterinarian and 28 days post ovulation and again at 60 days.
 - G. Purchaser agrees that chilled semen requires special handling and that attempts to breed any mare outside controlled condition of an equine reproductive center can greatly reduce, and in some cases prevent chances of conception.
 - H. Purchaser agrees to return all insemination certificates to Castle Ranch, Inc. within 30 days of insemination. Failure to comply could inhibit registration of resulting foal.

Return of Service

- A. The purchaser is entitled to 2 semen shipment per estrus cycle, for no more that 3 cycles per breeding season.
- B. All terms within the stallion service contract concerning the live foal guarantee will be honored.

Non-Assignment

- A. This contract cannot be assigned of transferred by purchaser.

Liability

- A. Castle Ranch, Inc. is not responsible for lost, delayed, or damaged semen and makes no representatives or warranties of any kind with respect to semen except that it is the stallion's and is viable semen at time of shipment.
